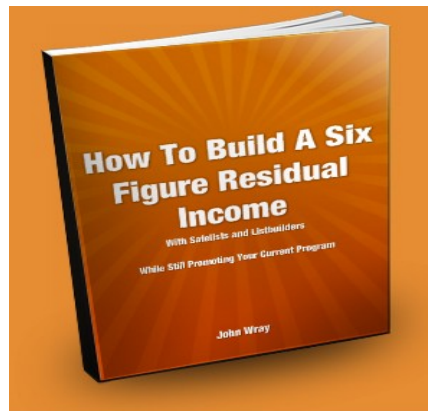

Chapter One

The Complete Overview

OK..... right to the chase.

You do not have time for pages of information without an idea of where this is going.

This report will show you how to put into motion, or prime the pump, so to speak, to begin to receive ongoing, direct pay residual income that can compound and grow on its own once it is started.

It is perfect as an additional income to whatever you are doing now, or as a low cost feeder program if you promote a higher cost program. It can also be built to any level of income as a primary business.

There is no limit or ceiling to the income that can be generated.

There are no special skills needed.

You do not need a website, blogs, tools, software, OR ANYTHING ELSE.

Quite simply, the report will go into the easy to understand details of the what, why, and how to build a six figure ongoing residual income in eight months or less.

That is a annual residual income of over \$100,000 in eight months.

All that is needed to succeed is to do what you are already doing, which is send out emails using safelists and listbuilders. You responded to one to get this report. Others will respond to yours.

Read the entire report to see exactly how you can benefit financially.

Chapter Two

The Criteria and the Program

In order to meet our goal that **ANYONE** can attain a growing residual income using safelists and list builders, we must use an existing income producing program. In choosing a program, certain criteria must be met.

- 1) It must be a good product and it must be affordable so that virtually anyone can join. Because we want residual income, any program we use will have a monthly cost. It must be something everyone can afford.
- 2) It must be established and have a successful track record of people making money. In other words, no new start ups.
- 3) It must have a fast break even point. We want people to be able to join and immediately break even and then get into profit. There must be no long waiting to start making money.
- 4) It must have a compensation plan that is easy to understand.
- 5) It must have a compensation plan that rewards **EVERYONE** the same, no matter when they join or who they join under. In other words, it cannot be a program where only the people at the top are making good money. It cannot be a program where there is any benefit to be gained by joining under a certain member. It must reward all members the same.
- 6) It must have a high retention rate. In other words, it must quickly get a member into profit. People making a profit do not quit something that is bringing in money.
- 7) It must be easily duplicated. It must be easy to share with others, either to those a person knows, or by marketing.
- 8) It must be infinitely scalable, or in other words, it must have no ceiling on income potential for those who desire to build a large income.

The program that is used to build residual income is called Infinity Downline. Before examining the details of how Infinity Downline meets or exceeds all of the required criteria, I would like to give you some general information about the program.

Infinity Downline is really a hybrid program. It is a membership site. The content in the member area is a large educational audio and video library. A member pays a small monthly membership fee for access to the member area and for inclusion in the affiliate income opportunity. The income compensation plan is an affiliate model. That is, as an affiliate, a person introduces others to the Infinity Downline membership program and audio/video library. The affiliate then receives monthly income from the members they have introduced.

There will be a much more thorough explanation of the income compensation plan later in the report.

So, in general, Infinity Downline is a hybrid program. It melds a paid membership site with an affiliate program. The affiliate program promotes the membership site and pays the affiliate a monthly income.

It is not a Multi Level Marketing program where matrices of distributors are built below you. Every member in your downline is on one level and you receive the same amount of commission from every member. This is important, because the idea of a downline usually brings to mind Multi Level Marketing. This is not the case with Infinity Downline. All members below you are on one level and would be better described as a powerline. So to be clear, Infinity Downline is not Multi Level Marketing.

Now, I want to add a personal note. Not all will agree with me here. I admit it is a personal preference, but I want to share it for those who do agree with my opinion My opinion here is not about the audio/video library part of the member's area. My opinion here is about the main page of the site that a new visitor first sees. I personally do not like the style, or feel of the page. For me, it is too over the top. I personally do not like the pictures of palm trees and the videos. It is too much hype for my tastes. I am sure some will not agree with me and some will.

Here is a quote from the site that addresses this concern:

“ I have to admit, the site is designed to be flashy and with hype and pop to it. “

I include my opinion here for those, who like me, are not a fan of the style of the site at first glance. I encourage you to look beyond what you think you might not like at your first visit because the membership site and the income opportunity are stellar.

We will now examine how Infinity Downline meets or exceeds all the criteria we require.

- 1) It must be a good product and affordable enough for anyone to join.

The Audio/Video Library is the product in the member area. It is an excellent educational resource. There is everything from training on Microsoft Excel and Word to website building to Ebay to Affiliate Marketing and more. There are literally dozens of categories full of multiple audios and videos on all kinds of subjects. Have you seen the Video Professor educational DVDs marketed on TV? It is much like that with a large catalog of subjects. There is far too much to list here. Find out more on the Infinity Downline site. This report is primarily about building an income, so detailed information concerning the contents of the membership site will not be expanded on here.

As for being affordable, the monthly fee is just \$25. This is affordable for virtually everyone. \$25 a month is less than one dollar a day or about \$6.25 a week. **Where else can you literally start your own unlimited income business for \$25 a month? Later in the report, I will show you how quickly you can build a SIX FIGURE ANNUAL INCOME with Infinity Downline using this report.** Using this report, many people break even on their \$25 monthly fee on their first day.

For those who may be thinking that you cannot afford \$25 a month, how does that make you feel? If you are so close to the edge that an investment in yourself of eighty-one cents a day is too much, you really *do* need something to increase your income. You might do well to re-evaluate your budget and use **How To Build a Six Figure Residual Income With Safelists and List Builders as the vehicle to increase your income. Keep reading for all the details.**

- 2) It must be established and have a successful track record of people making money.**

Infinity Downline has been in operation for over two years. It is a part of Multi Plex Systems, a debt free company that has been in business over twelve years and operates a number of successful businesses. At the time of this writing, there are 141,396 members in Infinity Downline. These members are making a growing monthly residual income.

- 3) It must have a fast break even point.**

This is one of the many ways Infinity Downline is heads above most programs. The monthly fee to be a member is \$25. On your FIRST referral, you receive the whole \$25 directly from that new member, and the whole \$25 from that member every month they remain in Infinity Downline.

This is why many using **How To Build a Six Figure Residual Income With Safelists and List Builders break even on their first day. You break even with one referral, and you will find out later how easy that is to do using this report.**

- 4) It must have a compensation plan that is easy to understand.**

Infinity Downline uses what is called a REVERSE TWO UP compensation plan.

It is designed so that a member will have a continually growing downline and income by just referring only four members.

Here, in one sentence, is the compensation plan.

Each person you refer to the program or is passed up to you in the program pays you \$25 per month, with the exception of your second and fourth referrals, who are passed up to your sponsor and put in their downline.

While it can be stated in one sentence, it **MUST** be fully understood to see the power of the compensation plan.

Here are the basics of a reverse two up plan.

Your first referral is in your immediate downline.

Your second referral is passed up to your sponsor and is put in their downline.

Your third referral is in your immediate downline.

Your fourth referral is passed up to your sponsor and is put in their downline.

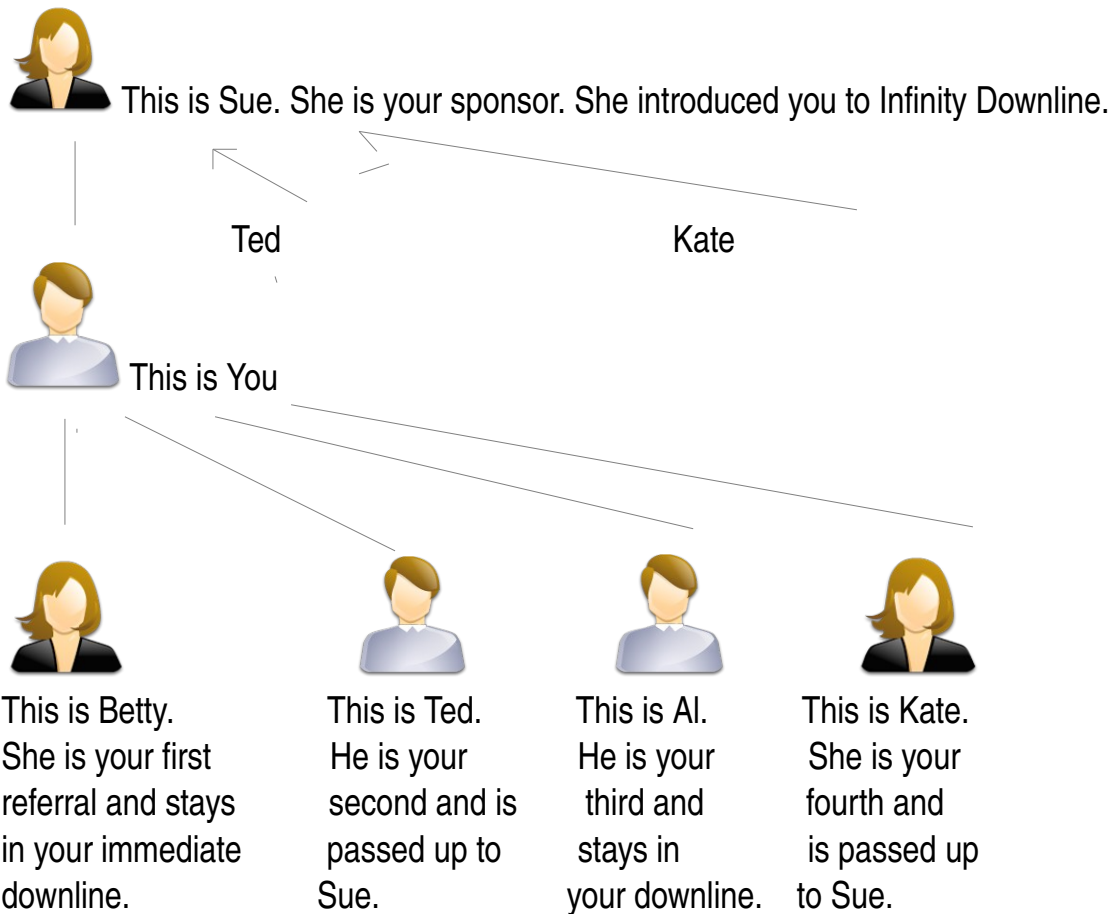
EVERY referral after those first four goes into your immediate single level downline.

The information in this section is of extreme importance to understand the power and ease of building a substantial income with Infinity Downline using this report.

By using the How To Build a Six Figure Residual Income With Safelists and List Builders report to help build your business, you will have a clear explanation of the compensation plan to show others how powerful the income growth is.

Quite simply, your income grows by helping others learn how to grow their income. You do this by sharing the information in this report.

If you are in the substantial group of people whose eyes glaze over at a written explanation of a compensation plan, look at the following diagrams beginning on the next page to visualize the basics.



After your first four referrals you are identified as QUALIFIED and **EVERYONE** you refer from that point on stays in your immediate single level downline. You do not pass up any more after the second and fourth.

Just a word here about the term downline. Again, this is not multi level marketing. You are not building multiple levels of downline. A better term to use is powerline.

Look now at what that means after you have your four referrals.



Sue Sue remains your sponsor. Your \$25 per month is paid to her. You passed up Ted, your second referral, and Kate, your fourth referral, to Sue. They pay their \$25 per month to Sue.

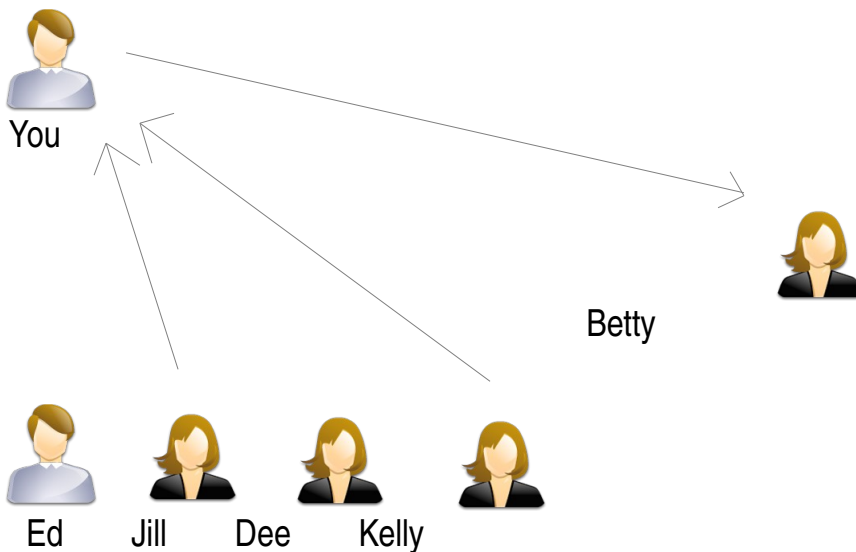
So, let's look at where you are at this point. You are identified as QUALIFIED because you have completed your two required pass ups. You have Betty, your first referral, and Al, Your third referral under you in your downline. They pay you \$25 per month. So, what happens when you continue to refer more members?



This is important to understand the compensation plan. After you have passed up the only two referrals you will ever have to pass up, every person you refer from then on is directly under you in your SINGLE LEVEL downline. It does not matter if you refer 10 or 10,000 people, every one of them will be on your immediate single level downline. This is not multi-level marketing where your additional referrals begin to be placed in multiple levels of downlines below you. **Every one pays you \$25 per month.**

The following is doubly important to understand the compensation plan. Every person in your single level downline will pass up two of their referrals to YOU, just like you passed up two to your sponsor. Those that are passed up to you are placed in your downline as a new referral JUST AS IF YOU REFERRED THEM.

Look at this diagram to see what happens when Betty, your first referral, begins her business.



Betty's first four referrals are Ed, Jill, Dee, and Kelly. Her second and fourth, Jill and Kelly, are passed up to you. Now Jill and Kelly are brand new members in your immediate downline just as if you referred them. They will pay you \$25 every month and they will pass up THEIR second and fourth referrals to you.

This happens with every one of your referrals, whether you personally referred them or they were passed up to you.

Your downline *compounds* as those who are passed up to you each pass two of THEIR new referrals to you.

Every member directly under you, including those you personally sponsor and those who are passed up to you are on the same level and each pays you \$25 per month. Compare that to other programs where commissions are as little as \$1 per month per member.

The TWO UP of the term REVERSE TWO UP just means that two referrals are passed up to your sponsor. The REVERSE means that it is the second and fourth that are passed up to the sponsor instead of the first and third that would be passed up in a regular two up plan.

The reverse is preferable because you keep your first referral. In Infinity Downline, that means you break even on your \$25 monthly fee on your FIRST referral.

NOW, THE FOLLOWING IS VERY IMPORTANT!

Many people who are not familiar with the reverse two up plan recoil in horror when they are told that they must pass up two of their referrals.

Many think, I cannot sponsor people in the first place, and then I have to give up two? That sounds too hard.

The How To Build a Six Figure Residual Income With Safelists and List Builders Report will make it easy to sponsor as many as you like. KEEP READING!

And as far as giving up two referrals?

DON'T THINK IT IS A BAD THING! IT IS A GOOD THING!

While the diagrams above attempted to illustrate the concept, the following written explanation will review the process because it is very important to understand the *compounding* power of the program. You will not find a better compensation plan. PERIOD.

You are not the only one that passes up referrals. Everyone does. You will see in a moment how powerful this is and how it will compound your income.

Look at it in the light of YOUR immediate referrals that you keep. Remember, your first and third referrals are in your immediate downline.

So, your first referral, Betty, passes up her second and fourth referrals to YOU. These new pass ups are now brand new members in your immediate downline, just as if they were your direct referrals. Each of THEM also will pass up their second and fourth, who are then in your immediate downline. This continues with each pass up you get. Each of them will pass up two.

That was with your first referral. Remember, your third referral, Al, is doing the same thing. He will pass up his second and fourth to you. They are then brand new members in your immediate downline. Then their second and fourth referrals pass up to you and so on.

Do you see the compounding power?

So, do not make the mistake of thinking that passing up two referrals to your sponsor is a bad thing. Think of it as a small, tiny little down payment on future compounding referrals that you do not have to sponsor.

While it is possible to stop at four referrals and just allow it to grow on its own, you do not have to stop there.

You are done with passing up referrals after you have passed up the second and the fourth. From then on, EVERY referral you sponsor is in your immediate downline, and EVERY ONE OF THEM will pass up two to you and give you more compounding. There is no limit to your income.

If you are still unclear on the power of the reverse two up compensation plan, please read this information again in point number four beginning on page 10.

- 5) **It must have a compensation plan that rewards everyone the same, no matter when they join or who they join under.**

This was a key factor for How To Build a Six Figure Residual Income With Safelists and List Builders. As you will see in a later chapter, this report is designed to help build your business. To do this, the program, in this case Infinity Downline, must reward everyone the same no matter when they join. In addition, there had to be no benefit in joining under a certain member.

Unfortunately, human nature being what it is, there are some people who try to position themselves if they feel they would benefit.

You see this in programs where downlines are built in a traditional matrix and there is the possibility of spillover. Some people will try to join under a heavy hitter in hopes of getting that spillover.

This also happens when programs start up and you are encouraged to get in quickly for the best positioning.

There is none of that here. The opportunity can benefit everyone equally no matter when they join and no matter who they join under.

There is no possibility of saturation or running out of people who might be interested in joining and making a home based residual income. Those who might think that are naive about the world population and the world economy.

It will benefit everyone no matter when they join and you can help others create their own income when they join under you.

In fact, because the complete How To Build a Six Figure Residual Income With Safelists and List Builders program is based on the premise of helping others, I, as the author, want to tell you something straight from the heart. If you decide to use How To Build a Six Figure Residual Income With Safelists and List Builders to build an income, join Infinity Downline from the person you received the report from. It is that person who made the effort to help you by making you aware of the report. There is no benefit to joining under anyone else.

6) It must have a high retention rate.

It is hard for most people to remain in a venture if they are seeing no results or profits. This is why so many people fail in Network Marketing businesses. The building period where profits are not yet being produced is discouraging and unprofitable.

Infinity Downline was chosen for the How To Build a Six Figure Residual Income With Safelists and List Builders program for many reasons. One reason was the ability to break even almost immediately and then be in profit very quickly.

Many very well known residual income programs are based on a pay structure that breaks even with three referrals. It is the THREE AND YOU'RE FREE model. In other words, you are paid enough to cover your monthly fee by the commissions you receive for your first three referrals.

There is nothing wrong with that model. There are people who build their incomes with those programs to great levels. To start, though, you need three referrals to break even.

With Infinity Downline, you break even on your first referral. You pay \$25 to join. Your first referral pays you \$25 and you break even. On top of that, it is a direct member to member pay system so you are paid immediately. The Infinity Downline membership software keeps track of and handles the payment processing.

Your second referral is passed up to your sponsor, and then your third referral pays you \$25 per month and you are in profit.

Now answer these questions. Would you quit a program you are breaking even or making a profit in? Would you quit if your profit will grow as your referrals pass up more members to you? Of course you would not.

Infinity

Downline has a high retention rate because members are in profit quickly. There are over 141,000 members and growing.

- 7) It must be easily duplicated. It must be easy to share with others, either to those a person knows, or by marketing.**

By using the How To Build a Six Figure Residual Income With Safelists and List Builders report, you will easily attract referrals by helping people get what they want, which is information on how to easily start and grow a residual income from home. You will have what they are looking for and when you supply them with the knowledge and clear cut plan, they will join you.

Many people make the mistake of marketing a replicated affiliate website. That is, they join a program and get their own affiliate link for the program. The affiliate link takes a visitor to the program site, but is coded with the affiliate's ID so they get the credit for the referral.

This results in perhaps thousands of people marketing the same look alike site.

Those that try this rarely see success and they get discouraged and quit. Then they usually blame the program and think nothing works.

The truth is that marketing a replicated website is a bad idea. There is no way to distinguish yourself from the thousands of others marketing the same look alike website.

By using this report, you will easily attract others by giving them a solution to what they want and need in a clearly presented manner.

- 8) **It must be infinitely scalable. In other words, it must have no ceiling on income potential for those who desire to build a large income.**

Infinity Downline is infinitely scalable. Because it is not a Multi Level Marketing business, and every referral is on your single level powerline, it can be expanded to any level of income that you desire. After the first four referrals, every single referral goes into your own downline. There is no limit to the number of personal referrals or pass up members anyone can have. It simply can be built into as large a business as you like, with every member in your downline paying you \$25 per month.

Chapter Three

Overview of Income Growth

This chapter will give you an idea of the income potential of the program.

The example given will illustrate on a month by month basis how income growth can occur.

Keep in mind that it costs you just \$25 per month to be in the program and you receive \$25 per month PER MEMBER in your downline.

For those reading this that are experienced, you see that this is 100 per cent pay out. It is TRUE. There are no admin fees. You pay \$25 as a member, and you receive \$25 PER MEMBER in your downline. There is information on the Infinity Downline site to explain how they are able to do this with no admin fees. You will not find a better pay plan. Period.

The potential income growth example will assume that you and each other member will sponsor only four members and will completely stop sponsoring after four.

The example will also assume that you will sponsor your four referrals in the first month and those referrals do no sponsoring in that month.

The second month they refer their four and their referrals do no sponsoring in that month, and so on.

The example assumes that each member will be motivated enough to build an income that they will take action and refer their four members.

In other words, this is a conservative example of potential growth. Most will begin to sponsor immediately. Most will not take a full month to refer four members, and most will refer more than four when using How To Build a Six Figure Residual Income With Safelists and List Builders.

Month One

After joining for \$25, you get your 4 referrals during the first month.
You pass 2 up to your sponsor.
You now have 2 in your downline.
2 in your downline (2 X \$25) gives you a \$50 monthly recurring residual income.

For this example, you are now DONE sponsoring! Of course, you CAN and I am sure you will continue once you get started.

Month Two

The 2 in your downline each get their 4 referrals.
Both of these 2 in your downline pass up 2 to you, for a total of 4 pass ups.
Your Month One downline of 2 plus these 4 gives you a total of 6 in your downline.
6 in your downline (6 X \$25) gives you a \$150 monthly recurring residual income.

Month Three

The 4 pass ups you received in Month Two get their 4 referrals.
Each of these 4 pass up 2 to you, for a total of 8 pass ups.
Your Month Two downline of 6 plus these 8 gives you a total of 14 in your downline.
14 in your downline (14 X \$25) gives you a \$350 monthly recurring residual income.

Month Four

The 8 pass ups you received in Month Three get their 4 referrals.
Each of these 8 pass up 2 to you, for a total of 16 pass ups.
Your Month Three downline of 14 plus these 16 gives you a total of 30 in your downline.
30 in your downline (30 X \$25) gives you a \$750 monthly recurring residual income.

Month Five

The 16 pass ups you received in Month Four get their 4 referrals. Each of these 16 pass up 2 to you, for a total of 32 pass ups. Your Month Four downline of 30 plus these 32 gives you a total of 62 in your downline. 62 in your downline (62 X \$25) gives you a \$1,550 monthly recurring residual income.

Let's stop here for a moment and look at what has happened in this example within five months. You received and read How To Build a Six Figure Residual Income With Safelists and List Builders and decided in your mind to use it to change your financial life.

You joined Infinity Downline, rebranded this report for free, and by showing others the information in How To Build a Six Figure Residual Income With Safelists and List Builders, found just four others within one month who wanted or needed to increase their income. After that first month, you basically did nothing but watch your downline and income grow.

After Five Months, you have an automatic recurring residual income of \$1,550.

Is that enough to replace your income or quit your job? Probably not. But what could it do for you? Pay your mortgage? Pay off debts? Put more in savings?

This is passive income coming in month after month. Will you have any trouble finding a good use for it?

Well, keep reading, because the compounding does not stop at five months!

And remember. You do not need to stop referring after your first four, and you certainly do not have to take a full month to find four people. Refer more and your income will grow at a much more rapid rate.

Month Six

The 32 pass ups you received in Month Five get their 4 referrals.

Each of these 32 pass up 2 to you, for a total of 64 pass ups.

Your Month Five downline of 62 plus these 64 gives you a total of 126 in your downline.

126 in your downline ($126 \times \$25$) gives you a \$3,150 monthly recurring residual income.

Month Seven

The 64 pass ups you received in Month Six get their 4 referrals.

Each of these 64 pass up 2 to you, for a total of 128 pass ups.

Your Month Six downline of 126 plus these 128 gives you a total of 254 in your downline.

254 in your downline ($254 \times \$25$) gives you a \$6,350 monthly recurring residual income.

Month Eight

The 128 pass ups you received in Month Seven get their 4 referrals.

Each of these 128 pass up 2 to you, for a total of 256 pass ups.

Your Month Seven downline of 254 plus these 256 gives you a total of 510 in your downline.

510 in your downline ($510 \times \$25$) gives you a **\$12,750 monthly recurring residual income. That is a \$153,000 annual income.**

Stop here again for a moment. **This is a five figure monthly or a six figure annual residual income in eight months.**

Feel free to figure out what happens in later months as your income grows. I will stop here because I wanted to show you a conservative timetable with figures on how to reach a five figure monthly residual income.

It is a conservative timetable because it is assuming each member will take a full month to find just four people who want or need to increase their income or start their own business.

The example does assume that each member will be motivated enough to build an income that they will take action and refer their four members.

By using How To Build a Six Figure Residual Income With Safelists and List Builders to help others who want to increase their income, you will find it easy to refer others.

Can you do this?

Yes.

You can do this.

Is there some effort involved?

Yes.

There is some effort involved.

But is it hard?

No.

It is not hard.

There are literally millions of people on safelists, list builders, and other advertising sites who are looking for this solution.

You will see later that it can be as easy as suggesting to people that they read this report.

Chapter Four

The Goal For Success

This chapter will outline the major goal for success with How To Build a Six Figure Residual Income With Safelists and List Builders, list the milestone goals to achieve it, and list the steps to make it happen.

If you simply *decide* to achieve the main and milestone goals, and determine in your mind that you will persevere until they are reached, you will succeed and build a growing residual income.

Decide you will be passionate in your effort.

Decide you will be focused on achieving the goals.

Decide you will have the drive to complete the goals.

Decide you will have the persistence to complete the goals.
